Pediatric surgery 6. Functional diagnostics 7. Neurologic According to the project in a complex the medical research department, the educational center with teaching not all-school disciplines (esthetics, ethics, art, computer literacy, foreign languages) had to work, the main emphasis was supposed on passing of rehabilitation and treatment, will be to be given to children and matters from the remote areas, to orphan children, children from needy families. Since spring of 2005 the construction of a complex was suspended. Block polyclinics were complete, one sleeping block, clinical laboratory, halls of applied art and celebrations. Aren't finished – the second sleeping block, the block biochemical laboratory, dining room, **cooking block** (generally the finishing works and roof) and territory arrangement. First of all it is necessary to finish the construction works on a building roof. 2.5. Current project status On this project there is a territory in 13,5r hectare, complete four blocks of a complex, with a functioning polyclinic and clinical laboratory. If it's necessary it is possible to involve one sleeping case and hall of applied art and celebrations. The decision on function expansion is made complex for the purpose of servicing not only children and their mothers, but all needing citizens the republic and citizens of neighboring states in recovery treatment. There are unique medical devices for diagnosings and treatments of diseases (for example, computer tomograph and row other, the list of the equipment is attached).

General description

This complex is equipped with unique medical devices for diagnosing and carrying out qualified treatment (appendix 1). Which are at present in failure to act.

Relevance of such institutions amplified after April events of 2010 when children were exported from the southern regions of the republic for all summer on the lake Yssyk-Kul coast, for rehabilitation. Besides with input of this complex need for inhabitants of this region would disappear to go to the capital for diagnosing, in particular inspection on the computer tomograph, biochemical analyses and a row other.

This project on maternity welfare and the childhood was begun in 1998 at the initiative of MBF "Meerim" included construction of a children's rehabilitation complex.

The location of this complex was chosen taking into account climatic, balneal conditions promoting fuller rehabilitation and treatments of children including mothers, the main emphasis on passing of rehabilitation and treatment was supposed, will be given to children and matters from the remote areas, to orphan children, children from needy families. For a complex the place on the northern coast of the Lake Issyk Kul was allocated.

The project of a complex was prepared by Kirgyzgiprstoy design institute on a competitive basis. According to the project, the complex consists of 8 blocks where shall the following departments are placed:

- 1 . the allergic
- 2 . the oncological
- 3. pulmonologichesky
- 4 . obstetrics and gynecology
- 5 . pediatric surgery
- 6 . functional diagnostics
- 7. the neurologic

According to the project the complex shall accept 250 sick children, including mothers.

Also according to the project in a complex the medical research department, the educational center shall work with teaching not all-school disciplines (an esthetics, ethics, art, computer literacy, foreign languages).

Since spring of 2005 (after March events) the construction of a complex was suspended. The block polyclinics, one sleeping block, clinical laboratory, halls of applied art and celebrations (from above 60%стоимостью about 18,0 mln. dollars of the USA in the prices of 2011) were complete.

Aren't finished – the second sleeping block, the block of biochemical laboratory, a dining room, the cooking block (generally finishing works and a roof) and territory arrangement.

According to technical data sheet on a complex of May 31, 2006, the total built-up area constitutes – 838,2 sq.m total area of the parcel of land of 13,5 hectares. And total area of a complex according to the act (of June 20, 2003) the working commission about acceptance for operation of the building (block E) finished by construction, constructions, rooms constitutes – 3820,5 sq.m. From them the usable space – 2588,8 sq.m.

From 17.08.2007 of No. 287-r the Children's medico-social rehabilitation Altyn-Balalyk complex (MSRK) was transferred by the order of the Government of the Kyrgyz Republic to temporary operational management to Territory Ministry of Health.

According to the decision of interdistrict court of Issyk kul area of the Kyrgyz Republic of the October 21, 2008, the upheld resolution judicial board on administrative and economic cases of the Supreme Court of the Kyrgyz Republic of April 14, 2009 (Case No. ED-335/8mk and / π No. 06-00042/09 ED), the property complex of the Children's medico-social rehabilitation complex located at the address Issyk kul area, of Cholpon-At, yπ Akhmatbay-ata No. 1, the Order of the Government of the Kyrgyz Republic No. 354 of June 27, 2009, is accepted in state-owned property and transferred to operational management to Ministry of Health of the Kyrgyz Republic.

Since August 2, 2010 of MSRK "Altyn-Balalyk", it was renamed into the medico-rehabilitation Den-Sooluk complex with expansion of functions of a complex for the purpose of servicing not only children and their mothers, but all needing needy citizens of the republic in recovery treatment.

For the period 2005-2011 due to the lack of financing on object aren't conducted construction works on construction completion.

At present the medico-rehabilitation Den-Sooluk complex has 13,5 hectares of the earth, the polyclinic and clinical laboratory starts functioning. If necessary it is possible to involve one sleeping case and halls of applied art and celebrations. There are unique medical devices for diagnosing and treatment of diseases (the list is attached).

The rehabilitation center has opportunity to render services in servicing of patients in the following directions:

- 1 . Acceptance of doctors (therapist, cardiologist, otolaryngologist, oculist, stomatologist, physiotherapist).
- 2 . Gynecologic services
- 3 . Services of a procedural office
- 4. Services of an office of functional diagnostics
- 5. Physiotherapeutic treatment
- 6. Balneotherapy
- 7. Mud cure
- 8. Ultrasonic research
- 9. Services of clinic of diagnostic laboratory
- 10 . Biochemical analyses
- 11. R-grafiya

All biochemical analyses are made on the EOS-BRAVO biochemical analyzer (Italy) under quality control and calibrations by control serum.

According to the reference of JSC of Kyrgyzgiprostroy Design institute of 25.04.2011 No. 111/02, for asset construction completion "Medico-rehabilitation the Den-Sooluk complex (бывш. MSRK "Altyn-Balalyk") estimated market value (investments) of object will make (without processing equipment) for 20.04.2011 - 459 223,319 thousand som or 9,771 mln. dollars of the USA (tab. 1).

First of all it is necessary to finish construction works on a building roof differently everything that is constructed, can become useless. These are works on the section I about 1-6 points (157 100 thousand som or 3 342,6 thousand dollars of the USA)

Now in addition to polyclinic functioning, and acceptance of vacationers in order that the complex started earning financial resources it is necessary to start the computer tomograph in work.

Experts from Phillips's local office on servicing of medical equipment assume that full start of the device, requires costs about 50 thousand dollars (including training of 4 skilled specialists from local staff for work on the device). But costs can be reduced. Table 2

Note: Preservation of the device occurred because of problems in an electronic payment and lack of the printer

So that to start the computer PQ 5000 tomograph 20 thousand dollars of the USA initially are necessary.

When functioning the device of costs in the amount of 20 thousand dollars of the USA it will be possible to recover approximately within two months.

If the cost of service is - 1700 som in case of acceptance in day of 10 patients:

1.1700 som x10чел. x 60 days = 1020000 som or about 22 thousand dollars of the USA Further the earned resources can be directed on completion of construction of the complex. If the polyclinic of a complex renders qualified medical services to the population of Cholpon-Ata and the visitor to vacationers and a season on the following types of service (tab. 3).
