

キルギス農業ビジネス投資フォーラム 2012 のご案内

キルギス共和国農業・土地改良省は、2012 年 9 月 13 日～14 日、キルギスの首都ビシュケクで、「キルギス農業ビジネス投資フォーラム 2012」を開催します。

このイベントは、ヨーロッパ連合代表、EU プロジェクト「キルギス共和国における農業加工セクター改善を通して経済的多様化を支援する」、持続的経済開発促進に関する GIZ プログラム、キルギス共和国商工会議所、その他国内および国際組織の支援と参加の下に実施されます。

フォーラムの主な目的は、投資家とキルギスの食品および加工業、特にミルク・肉・フルーツ・野菜の加工、小麦生産と製パン、農業および加工製品の有機生産からの代表者とのネットワーク構築を支援することにあります。

フォーラム開催時に、食品・農業製品の第 8 回国際トレードフェア「AgroProd Expo-2012」を開催します。フォーラム第 1 日目のキルギスへの投資機会とビジネスに関するプレゼンテーションの後で、このトレードフェアをご覧ください予定です。投資家にとって、キルギス国内の農産物・加工製品を知っていただく、そして生産者に関する幅広い情報を入手していただける良い機会となるでしょう。第 2 日目は、いろいろな分野のワーキンググループが、投資家との共同の可能性について議論をします。

フォーラムには、農業加工分野の外国企業や組織、キルギスで農業加工分野への投資を考えている関係者からの代表が招待されています。更に、農業・土地改良省は、フォーラム参加者の関心のある投資案件情報を準備しています。

外国からの参加者については、キルギス国内のフォーラム関連費用を主催者側で、すべて負担しますが、往復旅券（空・鉄道チケットなど）とビザの費用は、ご自身でご負担願います。


